The responsibility to view and inspect the cargo ship vessel at the designated location prior to submitting a bid lies solely with the bidder. The cargo ship vessel will be available for inspection during business hours from **July 8, 2026, to July 15, 2026.**

Requests to schedule a site visit must be submitted to the contact information provided below at least one (1) day before the intended visit date. The request should include the names of the individuals conducting the site visit as well as a copy of a government-issued identification card for each person. Please note that only those who have submitted a request in advance will be permitted to enter the premises.

A complete set of Bidding Documents will be available to interested Bidders from **July 1, 2026, until July 15, 2026** (except on Saturdays, Sundays, and Holidays), from 9:00 A.M. to 4:00 P.M. All interested bidders may inquire about or obtain the Bidding Documents at the CIIF-OMG, 4th Floor Palacio del Gobernador, Intramuros, Manila, or via email using the contact information provided below. All bidders who will participate in the bidding are required to obtain the Bidding Documents and pay a

non-refundable amount of **Php 2,500.00** in the form of cash or cashier's or manager's check for the bid documents before the deadline for submission of the bid proposal.

The description of an eligible bidder, documentary requirements, and other details on the bidding are contained in the Terms and Conditions and Instructions to Bidders.

Bidders are required to post/enclose a refundable Bid Bond in the amount equivalent to ten percent (10%) of the floor price. The bidding will be conducted through an open public auction procedure using a nondiscretionary "pass/fail" criterion.

Deadline for submission of bids will be on or before **July 15, 2026, at 9:30 A.M.** Opening of Bids will follow at 10:00 in the morning on the same day. Late bids will not be accepted. All bidders or their authorized representatives may attend during the Opening of Bids at the CIIF Conference Room, **CIIF-OMG 4<sup>th</sup> Floor, Palacio del Gobernador, Intramuros, Manila**, or via videoconference, the Zoom details of which will be provided upon submission of the bid. Results of the bidding shall be posted on the Bulletin and website to notify all concerned entities.
