INVITATION TO BID FOR THE SALES, MARKETING AND DISTRIBUTION OF MINOLA CONSUMER PRODUCTS

- 1. CIIF-OMG, through its Bids and Awards Committee, now invites bids for the Sales, Marketing and Distribution of Minola Consumer Products of San Pablo Manufacturing Corporation (SPMC).
- 2. Bidding shall be conducted through a Swiss Challenge/Competitive bidding procedure. Bidding is open to all interested Bidders/Challengers, subject to the conditions provided for under the Terms of Reference ("TOR"). Prospective Bidders/Challengers shall be evaluated based on their eligibility, technical, and financial qualifications, as provided and laid out in the TOR.

Interested Bidders/Challengers are required to submit their Letters of Intent to participate in the bidding not later than seven (7) days from the last day of the publication of the Invitation to Bid. The Letter of Intent to be submitted must be signed by the proprietor or by the president or by the managing partner of the Prospective Bidder/Challenger. Only Bidders/Challengers who duly submitted their Letters of Intent shall be allowed to purchase Bid Documents and participate in the bidding.

A complete set of Bidding Documents may be acquired by interested Bidders/Challengers from 05 November 2021 to 26 November 2021 at 16th Floor UCPB Building, Makati Avenue, Makati City during Mondays to Fridays, except holidays, from 8:00AM to 4:00PM and upon payment of the applicable fee for the Bidding Documents in the amount of FIVE HUNDRED THOUSAND PESOS (PHP500,000.00).
- 5. Bids must be duly received by the Bids and Awards Committee Secretariat through manual submission at 16th Floor UCPB Building, Makati Avenue, Makati City on or before 06 December 2021, Monday at 12:00NN. Late bids shall not be accepted. Unsealed or unmarked bid envelopes shall also be rejected.
- 6. Bid opening shall be on 06 December 2021, Monday at 1:30PM at 16th Floor UCPB Building, Makati Avenue, Makati City. The scheduled meeting may be accessed through zoom invite/link which will be given upon purchase of the bid documents. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
