Public Bidding for the Provision of Manpower Services for San Pablo Manufacturing Corporation, Granexport Manufacturing Corporation and Legaspi Oil Company, Inc.

**Project Number: SPMC-2022-001 (PhilGEPS# 8530675)**

**WHEREAS, SAN PABLO MANUFACTURING CORPORATION, GRANEXPORT MANUFACTURING CORPORATION and LEGASPI OIL COMPANY, INC.** (collectively as “CIIF Companies”) authorized the conduct of the Public Bidding for the *“Provision of Manpower Services for San Pablo Manufacturing Corporation, Granexport Manufacturing Corporation and Legaspi Oil Company, Inc.”*

**WHEREAS,** in accordance with the authority given by these CIIF Companies, and pursuant to the pertinent rules, the corresponding Invitation to Bid SPMC-2022-001 was advertised and published from 16 March 2022 to 23 March 2022 on: (1) the PhilGEPS Web Portal (Reference Number 8530675); (2) the Coconut Industry Investment Fund – Oil Mills Group (CIIF-OMG) website; and (3) a conspicuous place at the premises of the corporate headquarters of the CIIF Companies;

**WHEREAS,** in compliance with the pertinent provisions of the 2016 Revised IRR of RA9184, the invitation to observers from Commission on Audit (COA), Philippine Chamber of Commerce, Inc. (PPCI) and Transparency and Accountability Network (TAN) were served together with the schedule of Pre-Bid conference, Bid Opening, Bid Evaluation and Post-Qualification;

**WHEREAS,** the Bids and Awards Committee conducted a Pre-Bid Conference on 24 March 2022 at the corporate headquarter of the CIIF Companies located at 16<sup>th</sup> Floor UCPB Building Makati Avenue, Makati City;

**WHEREAS,** representatives from three (3) prospective bidders, namely, LSERV Corporation, Temps and Staffers, Inc. and Omniworx, Inc. attended the Pre-Bid conference, via zoom videoconferencing;

**WHEREAS,** on 05 April 2022, the scheduled date of opening of bids, no bid proposals were received;

**WHEREAS**, pursuant to Section 35.1(a) of the 2016 Revised IRR of RA9184, the Bids and Awards Committee shall declare a failure of Bidding when no bids are received;

**NOW, THEREFORE**, premises considered, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** to **RECOMMEND** to the Head of Procuring Entity (HOPE) the following:

- a. To **DECLARE A FAILURE OF BIDDING** for the "*Provision of Manpower Services for San Pablo Manufacturing Corporation, Granexport Manufacturing Corporation and Legaspi Oil Company, Inc.*" **DUE TO NON-SUBMISSION OF BIDS**;
- b. To **DIRECT** the Technical Working Group ("TWG") to conduct a mandatory review and evaluation of the terms, conditions and technical specifications of the Bidding Documents; and
- c. To **DIRECT** the BAC Secretariat to revise the bidding document as recommended by the TWG and proceed with the second public bidding.
