



**Coconut Industry Investment Fund – San Pablo Manufacturing Corporation**

**Resolution Number: SPMC-CB-2022-003**

Public Bidding for the Provision of Manpower Services for San Pablo Manufacturing Corporation, Granexport Manufacturing Corporation and Legaspi Oil Company, Inc.

**Project Number:** SPMC-2022-001B (PhilGEPS# 8596188)

**WHEREAS, SAN PABLO MANUFACTURING CORPORATION, GRANEXPORT MANUFACTURING CORPORATION and LEGASPI OIL COMPANY, INC.** (collectively as “CIIF Companies”) authorized the conduct of the Public Bidding for the *“Provision of Manpower Services for San Pablo Manufacturing Corporation, Granexport Manufacturing Corporation and Legaspi Oil Company, Inc.”*

**WHEREAS,** in accordance with the authority given by these CIIF Companies, and pursuant to the pertinent rules, the corresponding Invitation to Bid SPMC-2022-001 was advertised and published from 16 March 2022 to 23 March 2022 on: (1) the PhilGEPS Web Portal (Reference Number 8530675); (2) the Coconut Industry Investment Fund – Oil Mills Group (CIIF-OMG) website; and (3) a conspicuous place at the premises of the corporate headquarters of the CIIF Companies;

**WHEREAS,** in compliance with the pertinent provisions of the 2016 Revised IRR of RA9184, the invitation to observers from Commission on Audit (COA), Philippine Chamber of Commerce, Inc. (PPCI) and Transparency and Accountability Network (TAN) were served together with the schedule of Pre-Bid conference, Bid Opening, Bid Evaluation and Post-Qualification;

**WHEREAS,** the Bids and Awards Committee conducted a Pre-Bid Conference on 24 March 2022 at the corporate headquarter of the CIIF Companies located at 16<sup>th</sup> Floor UCPB Building Makati Avenue, Makati City;

**WHEREAS,** representatives from three (3) prospective bidders, namely, LSERV Corporation, Temps and Staffers, Inc. and Omniworx, Inc. attended the Pre-Bid conference, via Zoom Videoconferencing;

**WHEREAS,** on 05 April 2022, the scheduled date of opening of bids, no bid proposals were received;

**WHEREAS**, due to **non-submission of bids** and as shown by the BAC Resolution Number SPMC-CB-2022-001 attached hereto as **Annex "A"**, the public bidding contemplated by Invitation to Bid SPMC-2022-001 resulted in failure of bidding;

**WHEREAS**, due to the said failure of bidding, the CIIF Companies authorized the Bids and Awards Committee to conduct a Second Public Bidding for the *"Provision of Manpower Services for San Pablo Manufacturing Corporation, Granexport Manufacturing Corporation and Legaspi Oil Company, Inc."* with an Approved Budget for the Contract (ABC) amounting to **SIXTY-SEVEN MILLION NINE HUNDRED THIRTY-THREE THOUSAND SIX HUNDRED TWENTY-EIGHT PESOS AND 20/100 ONLY** inclusive of VAT (Php 67,933,628.20);

**WHEREAS**, pursuant to the authority given by the CIIF Companies, the Bids and Awards Committee, through its Secretariat, caused to be advertised and published the Invitation to Bid (SPMC-2022-001B) for the said Second Public Bidding from 11 April 2022 to 18 April 2022 on: (1) the PhilGEPS Web Portal (Reference Number 8596188.) [Annex "B"]; (2) the Coconut Industry Investment Fund - Oil Mills Group (CIIF-OMG) website; and (3) a conspicuous place at the premises of the corporate headquarters of the said CIIF Companies;

**WHEREAS**, in connection with the said Second Public Bidding, the Bids and Awards Committee conducted a Pre-Bid Conference on 19 April 2022 at the corporate headquarters of the CIIF Companies located at 16<sup>th</sup> Floor UCPB Building Makati Avenue, Makati City;

**WHEREAS**, the said Pre-Bid Conference was attended through Zoom Videoconferencing by the following : (1) LSERV Corporation; (2) Omniworx Inc. and with (3) COA representative as an observer;

**WHEREAS**, to address the issues raised during the Pre-Bid Conference, the Bids and Awards Committee issued the Supplemental Bid Bulletin, which is attached hereto as Annex "B", on 21 April 2022 and posted the same in the manner prescribed by pertinent laws;

**WHEREAS**, only one (1) prospective bidder, LSERV Corporation, purchased the Bid Documents for the said Second Public Bidding;

**WHEREAS**, on 04 May 2022 - the scheduled opening of bids, the abovementioned prospective bidder submitted its bid proposal and passed the preliminary examination of bids;

**WHEREAS**, on 05 May 2022 the Bids and Awards committee with the assistance of Technical Working Group conducted a Bid Evaluation of the bid proposal of the lone eligible bidder with the presence of an observer from Commission on Audit;

**WHEREAS**, the bid proposal of the lone eligible bidder was found to be substantially complying:

WHEREAS, during the post qualification of bids on 06 May 2022 and after careful examination, validation and verification of all eligibility, technical and financial requirements, LSERV Corporation being the Single Calculated Bid was found to be responsive and thus post-qualified;

NOW, THEREFORE, premises considered, We, the Members of the Bids and Awards Committee, hereby RESOLVE to RECOMMEND to the Head of Procuring Entity (HOPE) the following:

- a. To DECLARE LSERV Corporation as the Single Calculated and Responsive Bidder (SCRB);
- b. To RECOMMEND the Award of Contract for the Provision of Manpower Services of San Pablo Manufacturing Corporation, Granexport Manufacturing Corporation and Legaspi Oil Company, Inc. to LSERV Corporation with a bid amount of Sixty-Three Million Five Hundred Ninety-Five Thousand Five Hundred Forty-Three Pesos and 20/100 centavos (Php 63,595,543.20)
