The Supplemental/Bid Bulletin is issued to all prospective bidders to clarify, modify and/or amend items in the Philippine Bidding Documents: 1. Section I – Instructions to Bidders; 2. Section II – Bid Data Sheet and 3. Section VI – Schedule of Requirements as discussed and agreed during Pre-bid Conference held on November 2, 2022, for the above-mentioned project of Coconut Industry Investment Fund – Granexport Manufacturing Corporation.

The following clarification and amendments are provided for the guidance and reference of all prospective bidders:

**I. CLARIFICATION**

<b>QUERIES</b>	<b>CLARIFICATION/RESOLUTION</b>
1. What are the similar contracts for SLCC requirements and is it exclusive for government agencies?	1. The bidder's similar contract for SLCC requirement is for the Supply and Delivery of Industrial Chemical Products as stated in Section II – Bid Data Sheet. Contracts either from government agencies or private company. However, the bidder shall not be allowed to include contracts from CIIF Companies (Granexport Manufacturing Corporation, Legaspi Oil Company, Inc. and San Pablo Manufacturing Corporation)  The bidder's SLCC similar to the contract bid should have been completed within five (5) years prior to the deadline for the submission and receipt of bids (Page 19 – Bid Data Sheet)
2. Can a winning bidder be given a forecast for the required volume or quantity of Hexane to be delivered?	2. The winning bidder shall deliver the Hexane within two (2) weeks from receipt of Notice to deliver. The required volume/quantity of Hexane to be delivered to GRANEX per delivery is 25,000 liter (with +/- 1% to 2% tolerance). (Page 28 – Schedule of Requirements)  The bidder should have a stock of at
