

## CONTRACT AGREEMENT

THIS AGREEMENT is executed on 27 January 2023 in Makati City between:

**SAN PABLO MANUFACTURING CORPORATION ("SPMC")** is a non-chartered government-owned and controlled corporation (GOCC) and one of the six (6) oil mill/refinery companies comprising the Coconut Industry Investment Fund- Oil Mills Group (CIIF-OMG) holding office at 16<sup>th</sup> Floor, SEC Building, Makati Avenue, Makati City, represented here by its Acting President and Chief executive Officer, **CARLOS LUIS P. RABAT**, duly authorized for this purpose under BOD RESOLUTION No. 2023-\_\_, a copy of which is attached as Annex "A";

-and -

**JMA MACHINERY PARTS SUPPLIER ("JMA")**, a single proprietorship organized under Philippine laws with principal address at Block 1, Lot 15, Homepoint Village, Barangay San Isidro, Angono, Rizal, represented here by **JANUS MIGUEL C. AQUINO**, Manager, authorized for this purpose as shown by the Special Power of Attorney attached hereto as Annex "B".

WHEREAS, SPMC invited Bids for certain goods and ancillary services, particularly the procurement of one (1) unit Ammonia Compressor for SPMC and has accepted a Bid from JMA for the supply of those goods and services in the sum **TWO MILLION EIGHT HUNDRED THOUSAND PESOS (Php 2,800,000.00)**, inclusive of all government taxes (hereinafter called the "Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;



- iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the sum TWO MILLION EIGHT HUNDRED THOUSAND PESOS (PHP 2,800,000.00) for one (1) unit Ammonia Compressor, inclusive of all government taxes, JMA MACHINERY agrees to deliver the said goods to SPMC in accordance with its Bid.
  4. SPMC agrees to pay the above-mentioned sum in accordance with Clause 2.2, Section V of the Special Conditions of Contract.




