

CONTRACT AGREEMENT

THIS AGREEMENT made on the 12th day of January 2023 between GRANEXPORT MANUFACTURING CORPORATION of Makati City, Philippines (hereinafter called as "GRANEXPORT") of the one part and METROSHEN INTERNATIONAL CORPORATION (hereinafter called as "METROSHEN CORP.") of Makati City, Philippines of the other part;

WHEREAS, GRANEXPORT invited Bids for certain goods and ancillary services, particularly the procurement of Activated Carbon for GRANEXPORT and has accepted a Bid from METROSHEN CORP. for the supply of those goods and services in the sum TWO MILLION FIVE HUNDRED SEVENTY-SEVEN THOUSAND PESOS (Php 2,577,000.00) respectively, inclusive of all government taxes (hereinafter called the "Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the sum of TWO MILLION FIVE HUNDRED SEVENTY-SEVEN THOUSAND PESOS (Php 2,577,000.00) for Activated Carbon,

inclusive of all government taxes, METROSHEN CORP. agrees to deliver the said good to GRANEXPORT in accordance with its Bid.


4. GRANEXPORT agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


