

CONTRACT AGREEMENT (Manpower Services Contract)

07 OCT 2022

THIS AGREEMENT made on ___ day of September 2022 between GRANEXPORT MANUFACTURING CORPORATION of the Philippines (hereinafter called as "GRANEX") of the one part and LSERV CORPORATION of the Philippines (hereinafter called as "LSERV") of the other part;

WHEREAS, GRANEX invited Bids for certain goods and ancillary services, particularly the provision of manpower services and has accepted a Bid by LSERV for the supply of those goods and services in the sum of THIRTY-TWO MILLION SEVENTY THOUSAND EIGHT HUNDRED FORTY-SEVEN AND 20/100 PESOS (Php 32,070,847.20) inclusive of Value Added Tax [hereinafter called "the Contract Price"].

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the sum of THIRTY-TWO MILLION SEVENTY THOUSAND EIGHT HUNDRED FORTY-SEVEN AND 20/100 PESOS (Php 32,070,847.20) inclusive of Value Added Tax or such other sums as may be ascertained, LSERV agrees to provide MANPOWER SERVICES in accordance with its Bid.
4. GRANEX agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. No employer-employee relationship shall exist between GRANEX and the personnel assigned by LSERV by virtue of this contract. LSERV shall strictly observe and comply with all labor laws with regard to its workers/employees

including workmen's health and safety, workmen's welfare, compensation for injuries, minimum wages, hours of labor and other labor laws, holding GRANEX free and harmless from any liability arising from such obligations.

6. LSERV has not made and will not make any offer, promise to pay or authorization of the payment of any money, gift or any other inducement to any official, political party, employee of the Government or any other person in contravention with applicable laws in connection with the execution of this Contract and performance of its obligations thereunder. Violation of this provision shall be a ground for immediate termination of this Contract.
7. LSERV shall not assign this Contract or sub-contract the performance of any portion of it, without GRANEX's prior written consent. Prior to the assignment or subcontracting and the approval by GRANEX thereof, LSERV must disclose to GRANEX the name of its assignee/s or subcontractor/s who/which should have a written agreement/s with the Service Provider indicating: (i) that the assignee/s or subcontractor/s is aware of and shall abide with all the terms and conditions of this Contract, as may be applicable; (ii) that the term of the assignment/sub-contract shall not exceed the term of this Contract; and (iii) the detailed terms of the assignment/sub-contract
8. LSERV shall pay taxes in full and on time.
9. LSERV is likewise required to regularly present, within the duration of the Contract, a tax clearance from the Bureau of Internal Revenue ("BIR") as well as a copy of its income and business tax returns duly stamped and received by the BIR and duly validated with the tax payments made thereon.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.




