4.	What is the EIS Cert? Is it the winning bidder who will provide the EIS to SPMC?	4. It is the Bureau of Internal Revenue (BIR) who will issue the EIS Certificate. However, it is the responsibility of the winning bidder to assist and facilitate the SPMC in securing the EIS Certificate from the BIR. The SDTS is the middleware that will connect with the BIR. All of the sales transactions of SPMC to be submitted to BIR will be through the EIS Middleware. The CIIF Companies has already an existing invoicing system, what is needed is only the middleware. It is the responsibility of the bidder to integrate the SDTS system with the BIR-EIS.
5.	Can a bidder participate even if the software is not yet registered with the BIR?	5. The software must be BIR registered.
6.	Up to what extent can the winning bidder assist the SPMC for the EIS Certificate?	6. The winning bidder shall assist the SPMC until the issuance of Permit to Transmit (PTT) by the BIR.
7.	How about the Database?	7. The Database Administration shall be with CIIF-OMG
8.	What is going to update by the winning bidder?	8. The winning bidder shall update the software itself. In updating the software, it is only the tool which needs to be updated.
9.	Is it possible that the bidder has not yet develop the middleware?	 The bidder shall have an existing or developed middleware in order to deliver the same on or before June 1, 2023.
10.	Is there already an existing sandbox?	10. The BIR will provide the testing environment.
11.	How can the bidding submit their bid for three (3) companies?	11. The bidder can submit their bid for three (3) companies consolidated in one (1) envelop since the eligibility requirements for the three (3) companies are the same except for the following: a) SLCC requirement (50% of ABC per company); b) NFCC computation per
