1. Should the copy of the original bids must be certified true copies?	For the duplicate copy envelop, submission of photocopies of the original submitted bid is sufficient. (Reference Bid Data Sheet, Clause 15, page 21)
2. Can the BAC consider if the bidder cannot provide the contract agreement with its client during post-qualification as attachment for the statement of on-going government contracts due to confidentiality issue and Non-disclosure agreement?	The Notice of Award and Notice to proceed will suffice. However, considering that the Procuring Entity has the duty to verify, validate, and ascertain the authenticity of the submitted bids, the Bids and Awards Committee, through the Technical Working Group, may require the submission of additional document/s in support of the information being provided in the bidding documents that must be made available or accessible to the Procuring Entity during post-qualification.
