Whether or not the winning bidder is permitted to deliver more than 10,000 kg of Aluminum Sulfate per delivery	Yes, the winning bidder is allowed to deliver more than 10,000 kg of aluminum Sulfate per delivery. However, Granex will allow only a maximum of 20,000 kg per delivery.  (Ref. Page 31 – Schedule of Requirements)
