



**Coconut Industry Investment Fund – San Pablo Manufacturing Corporation (SPMC)**

**Resolution Number: SPMC-2023-001B-BAC4-01**

**Recommending the Award of Contract for the Procurement of Electronic Invoicing System (EIS) Middleware / Sales Data Transmission System**

**Project Number: SPMC-2023-001B (PhilGEPS# 9699508)**

**WHEREAS**, on March 21, 2023, the Bids and Awards Committee (BAC) issued its Resolution No. SPMC-2023-001-BAC4-01 declaring the 1<sup>st</sup> failure of bidding for the Procurement of Electronic Invoicing System (EIS) Middleware / Sales Data Transmission System (SDTS) due to post-disqualification of the bidder;

**WHEREAS**, during the pre-procurement conference (held on April 25, 2023), the BAC adopted the recommendation of the Technical Working Group to proceed with the 2<sup>nd</sup> Public Bidding for the Procurement of Electronic Invoicing System (EIS) Middleware / Sales Data Transmission System (SDTS);

**WHEREAS**, the approved Budget for the Contract (ABC) of the abovementioned project is Seven Million Six Hundred Three Thousand Nine Hundred Eighty-Seven Pesos and 77/100 (**P7,603,987.77**);

**WHEREAS**, the Bids and Awards Committee, through its Secretariat, advertised and published the Invitation to Bid (SPMC-2023-001B) for seven (7) calendar days from the date of its posting on April 27, 2023 on the following: (1) the PhilGEPS Web Portal (Reference Number **9699508**); (2) the Coconut Industry Investment Fund – San Pablo Manufacturing Corporation website; and at the (3) conspicuous places at the premises of the Coconut Industry Investment Fund-San Pablo Manufacturing Corporation;

**WHEREAS**, in compliance with the pertinent provisions of the 2016 Revised IRR of RA 9184, the invitation to observers from Commission on Audit (COA), Philippine Chamber of Commerce, Inc. (PPCI) and Transparency and Accountability Network (TAN) were served together with the schedule of Pre-Bid conference, Bid Opening, Bid Evaluation and Post-Qualification;

**WHEREAS**, the Bids and Awards Committee conducted a Pre-Bid Conference on May 5, 2023 at the Coconut Industry Investment Fund-San Pablo Manufacturing Corporation located at 16<sup>th</sup> Floor Securities and Exchange Commission Headquarters (formerly UCPB Building), Makati Avenue, Makati City;

**WHEREAS**, representatives from the prospective bidder, Malou Noscald and Jai Alas of Omniray Ventures, Inc., and Internal Audit Department, Rommel Renz Grapani and Dexter Delica attended the Pre-Bid conference via Zoom. However, no observers were present on the scheduled Pre-Bid.

**WHEREAS**, the BAC, as certified by the Secretariat, received bids for the above-mentioned procurement activity, to wit:

**WHEREAS**, on May 17, 2023 – the scheduled opening of bids, representative/s from the bidder/s attended the meeting, namely:



To **AWARD** the Contract for the Procurement of Electronic Invoicing System (EIS) Middleware / Sales Data Transmission System (SDTS) for San Pablo Manufacturing Corporation, Granexport Manufacturing Corporation and Legaspi Oil Company, Inc. to OMNIRAY Ventures, Inc. amounting to Seven Million Five Hundred Thousand Pesos (Php 7,500,000.00)
