For the computation of price schedule, the prospective bidder must use the updated SSS Circular No. 2022-033 for the SSS contribution. (Price Schedule – Annexes “D-1 to D-3”)
2. What supply does industrial type refer to?	2. The industrial type is the specification for hard hat. (Ref. pp 69-70 - List of Supplies to be provided by the Manpower Service Provider – Annex I.1)
3. Is the prospective bidder allowed to submit the clearance and/or certificate from Philhealth and Pag-IBIG for the remittances for the 2 nd quarter (April-June)?	3. The prospective bidder should have the Home Development and Mutual Fund (HDMF/Pag-IBIG) and Philippine Health Insurance Commission (PhilHealth) Clearance and/or Certificate issued within three (3) months from the date of the opening of bids.
