Recommending the Award of Contract for the Procurement of Stand-Up Pouch for Minola 200ml Lauric Oil for San Pablo Manufacturing Corporation

WHEREAS, on 17 August 2023, the Bids and Awards Committee (BAC) issued its Resolution No. SPMC-NP-2FB-2023-002B-BAC1-01 declaring the Failure of bidding for the Procurement of Stand-Up Pouch for Minola 200ml Lauric Oil due to non-receipt of;

WHEREAS, during the pre-procurement conference (held on August 4, 2023), the BAC adopted the recommendation of the Technical Working Group to proceed with the Negotiated Procurement – Two Failed Biddings for the procurement of Stand-Up Pouch for Minola 200ml Lauric Oil for San Pablo Manufacturing Corporation;

WHEREAS, the approved Budget for the Contract (ABC) of the abovementioned project is One Million Six Hundred Sixty-Six Thousand Three Hundred Fifty-Eight Pesos and 34/100 (Php 1,666,358.34);

WHEREAS, the Bids and Awards Committee, through its Secretariat, advertised and published the Invitation to Bid (SPMC-NP-2FB-2023-002B) for seven (7) calendar days from the date of its posting on September 5, 2023 on the following: (1) the PhilGEPS Web Portal (Reference Number **10096326**); (2) the Coconut Industry Investment Fund – San Pablo Manufacturing Corporation website; and (3) conspicuous places at the premises of the Coconut Industry Investment Fund – San Pablo Manufacturing Corporation;

WHEREAS, the Secretariat send the Request for Quotation to three (3) prospective Bidders, namely, Gilvan Packaging Corporation, Integrated Packaging Corporation and Primeflex Packaging Corporation;

WHEREAS, in compliance with the pertinent provisions of the 2016 Revised IRR of RA9184, the invitation to observers from Commission on Audit (COA), Philippine Chamber of Commerce, Inc. (PPCI) and Transparency and Accountability Network (TAN) were served together with the schedule of Pre-Bid conference, Bid Opening, Bid Evaluation and Post-Qualification;

WHEREAS, the Bids and Awards Committee conducted a Pre-Negotiation Conference on September 12, 2023 via Zoom through link Meeting ID 879 5834 7729 479860 and were attended by the following:

WHEREAS, to address the issues raised during the Negotiation Conference, the Bids and Awards Committee issued Bid Supplemental No. 1 (with reference number 10096326-01), which is attached hereto as Annex "A" and posted the same in the manner prescribed by pertinent laws;

WHEREAS, on September 19, 2023, during the scheduled opening of bids, examination of the submitted eligibility and technical documents, the BAC Secretariat certified that no bids were received;

WHEREAS, the BAC, as certified by the Secretariat, received quotation for the above-mentioned procurement activity, to wit:
