Recommending the Award of Contract for the Procurement of Various
 Laboratory Reagents and Chemicals for San Pablo
 Manufacturing Corporation

Project Number: SPMC-2023-022B (PhilGEPS# 10382642)

WHEREAS, on November 15, 2023, the Bids and Awards Committee IV (BAC 4) issued its Resolution No. SPMC-2023-022-BAC4-01 declaring the 1st failure of bidding for the Procurement of Various Laboratory Reagents and Chemicals due to non-receipt of bids and failure of the bidder to comply with the bidding requirements;

WHEREAS, during the pre-procurement conference (held on December 1, 2023), the BAC 2 adopted the recommendation of the Technical Working Group to proceed with the 2nd Public Bidding for the Procurement of Various Laboratory Reagents and Chemicals;

WHEREAS, the aggregated approved Budget for the Contract (ABC) of the abovementioned project is One Million One Hundred Fifty-One Thousand Eight Hundred Sixty-Six Pesos and 24/100 (**P1,151,866.24**);

WHEREAS, in compliance with the pertinent provisions of the 2016 Revised IRR of RA 9184, the invitation to observers from Commission on Audit (COA), Philippine Chamber of Commerce, Inc. (PCCI) and Transparency and Accountability Network (TAN) were served together with the schedule of Pre-Bid conference, Bid Opening, Bid Evaluation and Post-Qualification;

WHEREAS, during the scheduled Pre-Bid Conference on December 11, 2023 via Zoom through the link Meeting ID: 862 0848 1728 954103, no prospective bidders and observers were present;
