

AGREEMENT

This Agreement is executed this 7th of July 2023 at Makati City between:

GRANEXPORT MANUFACTURING CORPORATION (Granexport) is a non-chartered government-owned and controlled corporations (GOCC) and one of the six (6) oil mill/refinery companies comprising the Coconut Industry Investment Fund-Oil Mills Group (CIIF-OMG) holding office at 16th Floor Securities and Exchange Commission Headquarters, 7907 Makati Avenue, Salcedo Village, Barangay Bel-Air, Makati City, represented here by its Acting President and Chief Executive Officer, CARLO LUIS P. RABAT, duly authorized for this purpose under Board Resolution __, Series of __ (copy of which is attached as Annex A), hereinafter referred to as Granexport;

-and-

PETRON CORPORATION (Petron), a corporation organized under Philippine laws with principal office address at San Miguel Avenue, Barangay Wack Wack, Mandaluyong City, represented here by VIRGILIO V. CENTENO, Vice President, Industrial Sales and LEON G. PAUSING II, Assistant Vice President, Commercial Sales, authorized for this purpose under Resolution No. __, Series of __ (copy of which is attached as Annex B), hereinafter referred to as "Petron".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the sum of EIGHT MILLION THREE HUNDRED FOUR THOUSAND SEVEN HUNDREN SIXTY- EIGHT PESOS AND 40/100 (Php 8,304,768.40) for Automotive Diesel Oil (Diesoline), inclusive of all government taxes, Petron agrees to deliver the said goods to Granexport in accordance with its Bid.
4. Granexport agrees to pay EIGHT MILLION THREE HUNDRED FOUR THOUSAND SEVEN HUNDREN SIXTY- EIGHT PESOS AND 40/100 (Php 8,304,768.40).
5. This Agreement shall be subject to the review and approval of the Office of the Government Corporate Counsel. Any of its ensuing comments, recommendations, or directives shall form part of this Agreement.


