

**CONTRACT AGREEMENT  
(Security Services Contract)**

THIS AGREEMENT made on the 19<sup>th</sup> day of June 2023 between SAN PABLO MANUFACTURING CORPORATION ("SPMC") of the Philippines (hereinafter called "The Entity"), acting for itself and as the Procuring Agent of GRANEXPORT MANUFACTURING CORPORATION ("Granex"), LEGASPI OIL COMPANY, INC. ("LegOil") and SOUTHERN LUZON COCONUT OIL MILL, INC. ("SolCom"), of the one part and ALL NATION SECURITY AND INVESTIGATION SERVICES, INC. of the Philippines (hereinafter called "The Supplier") of the other part;

WHEREAS, The Entity invited Bids for certain goods and ancillary services, particularly the procurement of Security Services for CIIF-OMG and has accepted a Bid from ALL NATION for the supply of those goods and services in the sum of EIGHTEEN MILLION ONE HUNDRED SIXTY TWO THOUSAND SIX HUNDRED EIGHTY TWO PESOS AND 20/100 (Php 18,162,682.20) (hereinafter called "The Contract Price"), which is broken down on per company basis as:

SolCom	EIGHT HUNDRED THIRTY SIX THOUSAND THREE HUNDRED FOUR PESOS (Php 836,304.00)

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;

Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration of the sum of EIGHTEEN MILLION ONE HUNDRED SIXTY TWO THOUSAND SIX HUNDRED EIGHTY TWO PESOS AND 20/100 (Php 18,162,682.20) (hereinafter called "The Contract Price"), which is broken down on per company basis as:

or other such sums as may be ascertained, **ALL NATION SECURITY AND INVESTIGATION SERVICES, INC.** agrees to provide SECURITY SERVICES in accordance with its Bid.

4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. *Anti-Bribery Clause*

The SUPPLIER has not made and will not make any offer, promise to pay or authorization of the payment of any money, gift or any other inducement to any official, political party, employee of Government or any other person, in contravention with applicable laws in connection with the execution of this Contract and performance of its obligations thereunder. Violation of this provision shall be a ground for immediate termination of this Contract.
