

# Coconut Industry Investment Fund – Granexport Manufacturing Corporation (GRANEX)

Recommending the Award of Contract for the PROCUREMENT OF SUBMERSIBLE PUMP and declaration of Failure of Bidding for the PROCUREMENTOF MULTI STAGE VERTICAL PUMP for Granexport Manufacturing Corporation Project Number: GMC-2023-019 (PhilGEPS# 10202669)

WHEREAS, on January 27, 2023, the Board of Directors, as Head of the Procuring Entity (HOPE), approved the 2023 Annual Procurement Plan (APP) of Coconut Industry Investment Fund - Granexport Manufacturing Corporation (GRANEX) upon favorable recommendation of the Bids and Awards Committee (BAC);

WHEREAS, the APP contains the "PROCUREMENT OF VARIOUS PUMPS for Granexport Manufacturing Corporation" with an aggregated approved Budget for the Contract (ABC) amounting to One Million Two Hundred Fifty Thousand Pesos (P1,250,000.00), and shall be undertaken through Competitive Bidding;
