WHEREAS, on October 25, 2023, the Bids and Awards Committee III (BAC 3) issued its Resolution No. GMC-2023-017-BAC3-01 declaring the 1st failure of bidding for the Procurement of Various Shafting due to ineligibility of the bidder;

WHEREAS, during the pre-procurement conference (held on October 28, 2023), the BAC 3 adopted the recommendation of the Technical Working Group to proceed with the 2nd Public Bidding for the Procurement of Various Shafting for Granexport Manufacturing Corporation;

WHEREAS, the total approved Budget for the Contract (ABC) of the abovementioned project is One Million Five Hundred Eighty-Three Thousand Nine Hundred Eighty-Two Pesos and 40/100 (**P1,583,982.40**);
