This Supplemental/Bid Bulletin is issued to all prospective bidders to clarify, modify and/or amend pertinent items in the Philippine Bidding Documents as discussed and agreed during Pre-bid conference held on June 18, 2024 for the above-mentioned project of Coconut Industry Investment Fund – San Pablo Manufacturing Corporation (SPMC).

The following clarifications and/or amendments are provided for the guidance and reference of all prospective bidders:

**I. CLARIFICATIONS**

1. Should the supporting documents for the Statement of On-Going Government and Private Contracts, such as contracts and invoices, be submitted along with all the other eligibility requirements?	1. No. The supporting documents for the Statement of On-going Government and Private Contract will be submitted during post qualification process.
2. Is sub-contracting allowed?	2. No. Sub-contracting is not allowed.
3. Is there a required number of trucks?	3. SPMC does not require bidders to own a specific number of trucks. However, bidders must have adequate trucks readily available upon receiving a delivery request from SPMC.
4. Is JVA allowed?	4. Yes. However, SPMC requires prospective bidders to provide a duly signed Joint Venture
