WHEREAS, on 04 October 2024, the Bids and Awards Committee I (BAC 1) issued its Resolution No. LEG-2024-001B-BAC1-01 declaring the 2nd the failure of bidding for the Procurement of Supply of Labor, Material, Supervision and other consumable for Automation of Fire Suppression System of Legaspi Oil Company, Inc. due to ineligibility of the bidder;

WHEREAS, during the pre-procurement conference (held on October 10, 2024), the BAC 1 adopted the recommendation of the Technical Working Group (TWG) to resort to Negotiated Procurement-Two Failed Biddings for the procurement of Supply of Labor, Material, Supervision and other consumable for Automation of Fire Suppression System of Legaspi Oil Company, Inc.;

WHEREAS, the Approved Budget for the Contract (ABC) of the abovementioned procurement is Four Million Eight Hundred Thousand (Php 4,800,000.00);

WHEREAS, the BAC 1, through its Secretariat, advertised and published the Request for Quotation (LEG-NP-2FB-2024-001) for seven (7) calendar days from the date of its posting on October 11, 2024 on the following: (1) the PhilGEPS Web Portal (Reference Number 11349939); (2) the Coconut Industry Investment Fund – Legaspi Oil Company, Inc. website; and (3) conspicuous places at the premises of the Coconut Industry Investment Fund – Legaspi Oil Company, Inc.

WHEREAS, in compliance with the pertinent provisions of the 2016 Revised IRR of RA9184, the invitation to observers from Commission on Audit (COA), Philippine Chamber of Commerce, Inc. (PCCI) and Transparency and Accountability Network (TAN) were served together with the schedule of Pre-Negotiation conference, Opening of Quotations, Evaluation and Post-Qualification;

WHEREAS, the BAC 1 conducted a Pre-Negotiation Conference on October 18, 2024 via Zoom through link Meeting ID 822 5169 7483 793682 and was attended by:
