Recommending the Award of Contract for the Procurement of Manpower Services for San Pablo Manufacturing Corporation and Legaspi Oil Company, Inc.

WHEREAS, on 22 February 2024, the Board of Directors, as Head of the Procuring Entity (HOPE), approved the Supplemental Annual Procurement Plan Number of Coconut Industry Investment Fund - San Pablo Manufacturing Corporation (SPMC-SAPP-2024-001) and Annual Procurement Plan of Coconut Industry Investment Fund - Legaspi Oil Company, Inc. (LEG-APP-2024) upon favorable recommendation of the Bids and Awards Committee (BAC);

WHEREAS, the above SPMC-SAPP-2024-001 and LEG-APP-2024 contains the "PROCUREMENT OF MANPOWER SERVICES" for Coconut Industry Investment Fund - San Pablo Manufacturing Corporation (SPMC) and Coconut Industry Investment Fund - Legaspi Oil Company, Inc. (LEGOIL);

WHEREAS, SPMC is the procuring arm for the procurement of Manpower Services for SPMC and LEGOIL. The assignment and distributions of personnel are stated in the Bidding Documents;

WHEREAS, during the pre-procurement conference (held on 22 August 2024 and 24 August 2024, the Bids and Awards Committee I (BAC 1) adopted the recommendation of the Technical Working Group to proceed with the public bidding for the procurement of Manpower Services for SPMC and LEGOIL;

(PCCI) and Transparency and Accountability Network (TAN) were served together with the schedule of Pre-Bid conference, Bid Opening, Bid Evaluation and Post-Qualification;
