WHEREAS, on 09 August 2024, the Bids and Awards Committee I (BAC 1) issued its Resolution No. SPMC-2024-014B-BAC1-01 declaring the 2nd failure of bidding for the Procurement of PET Bottles for Minola Products for San Pablo Manufacturing Corporation due to non-receipt of bids;

WHEREAS, during the pre-procurement conference (held on 04 October 2024, the Bids and Awards Committee I (BAC 1) adopted the recommendation of the Technical Working Group to proceed with the 3rd public bidding for the procurement of PET Bottles for Minola Products for San Pablo Manufacturing Corporation;

WHEREAS, the Approved Budget for the Contract (ABC) of the abovementioned project is Five Million Two Hundred Eighty Thousand Pesos (Php 5,280,000.00);

WHEREAS, the BAC 1, through its Secretariat, advertised and published the Invitation to Bid (SPMC-2024-014C) for seven (7) calendar days from the date of its posting on October 5, 2024 on the following: (1) the PhilGEPS Web Portal (Reference Number 11326488); (2) the Coconut Industry Investment Fund – Oil Mills Group website; and (3) conspicuous places at the premises of the Coconut Industry Investment Fund – Oil Mills Group;

WHEREAS, in compliance with the pertinent provisions of the 2016 Revised IRR of RA9184, the invitation to observers from Commission on Audit (COA), Philippine Chamber of Commerce, Inc. (PCCI) and Transparency and Accountability Network (TAN) were served together with the schedule of Pre-Bid conference, Bid Opening, Bid Evaluation and Post-Qualification;

WHEREAS, the BAC 1 issued a Supplemental Bid No. 1 for the Postponement and rescheduling of Pre-Bid Conference posted on October 11, 2024 due to the declaration of suspension of work in government agencies in Pasay and Manila for the opening of APMCDRR, which is attached hereto as Annex "A" and posted the same in the manner prescribed by
