Recommending the Award of Contract for the Procurement of Various Plates for Granexport Manufacturing Corporation

Project Number: GMC-NP-2FB-2024-005 (PhilGEPS# 11222320)

WHEREAS, on 20 August 2024, the Bids and Awards Committee I (BAC 1) issued its Resolution No. GMC-2024-010B-BAC1-01 declaring the 2<sup>nd</sup> failure of bidding for the Procurement of Various Plates" for Granexport Manufacturing Corporation due to ineligibility of the bidder;

WHEREAS, during the pre-procurement conference (held on September 5, 2024), the BAC 1 adopted the recommendation of the Technical Working Group (TWG) to proceed with the Negotiated Procurement – Two Failed Biddings for the procurement of Various Plates for Granexport Manufacturing Corporation;

WHEREAS, the aggregated Approved Budget for the Contract (ABC) of the abovementioned procurement is Two Million Four Hundred Fifty-Seven Thousand Four Hundred Eighty-Seven Pesos (Php 2,457,487.00)
