WHEREAS, on 22 February 2024, the Board of Directors, as Head of the Procuring Entity (HOPE), approved the Supplemental Annual Procurement Plan Number of San Pablo Manufacturing Corporation (SPMC-SAPP-2024-001) and Granexport Manufacturing Corportaion (GMC-SAPP-2024-001) and Legaspi Oil Company, Inc. Annual Procurement Plan (LEG-APP-2024) for the Coconut Industry Investment Fund – Oil Mills Group upon favorable recommendation of the Bids and Awards Committee (BAC);

WHEREAS, the above procurement plans contain the "PROVISION OF SECURITY SERVICES for San Pablo Manufacturing Corporation, Granexport Manufacturing Corporation and Legaspi Oil Company, Inc." with an aggregated approved Budget for the Contract (ABC) amounting to Twenty Million Eighty Thousand Eighty-Three Pesos and 97/100 (Php 20,080,083.97), and shall be undertaken through Competitive Bidding;
