WHEREAS, on 07 August 2024, the Bids and Awards Committee III (BAC 3) issued its Resolution No. GMC-2024-011-BAC3-01 declaring the failure of bidding for the Procurement of Various Parts of Viking Pump (Item 3 - ROTOR SHAFT KK-124 and Item 5 - IDLER GEAR KK-124) for Granexport Manufacturing Corporation due to non-receipt of bids;

WHEREAS, during the pre-procurement conference (held on 01 October 2024 and 14 October 2024), the Bids and Awards Committee III (BAC 3) adopted the recommendation of the Technical Working Group to proceed with the 2nd public bidding for the procurement of Various Parts of Viking Pump for Granexport Manufacturing Corporation;

WHEREAS, the Approved Budget for the Contract (ABC) of the abovementioned project is Three Hundred Seventy Thousand Five Hundred Fifty Pesos and 40/100 (Php 370,550.40);
