Recommending the Award of Contract for the Procurement of Various Laboratory Supplies (for Microbial Tests) for San Pablo Manufacturing Corporation

WHEREAS, on 22 February 2024, the Board of Directors, as Head of the Procuring Entity (HOPE), approved the 2024 Supplemental Annual Procurement Plan Number 1 (SPMC-APP-2024-001) for the Coconut Industry Investment Fund – San Pablo Manufacturing Corporation (SPMC) upon favorable recommendation of the Bids and Awards Committee I (BAC 1);

WHEREAS, the SPMC-SAPP-2024-001 contains the "PROCUREMENT OF VARIOUS LABORATORY SUPPLIES (FOR MICROBIAL TESTS) for San Pablo Manufacturing Corporation" with an aggregated approved Budget for the Contract (ABC) amounting to One Million Three Hundred Forty-Eight Thousand Nine Hundred Sixty Pesos and 82/100 (Php1,348,960.82) and shall be undertaken through Competitive Bidding;

WHEREAS, during the pre-procurement conference (held on July 1, 2024 and July 2, 2024), the Bids and Awards Committee IV (BAC 4) adopted the recommendation of the Technical Working Group (TWG) to proceed with the public bidding for the procurement of Various Laboratory Supplies (for Microbial tests) for San Pablo Manufacturing Corporation;

WHEREAS, the BAC 4, through its Secretariat, advertised and published the Invitation to Bid (SPMC-2024-015) for seven (7) calendar days from the date of its posting on July 8, 2024 on the following: (1) the PhilGEPS Web Portal (Reference Number 11024924); (2) the Coconut Industry Investment Fund – San Pablo Manufacturing Corporation website; and (3) conspicuous places at the premises of the Coconut Industry Investment Fund – San Pablo Manufacturing Corporation;

WHEREAS, in compliance with the pertinent provisions of the 2016 Revised IRR of RA9184, the invitation to observers from Commission on Audit (COA), Philippine Chamber of Commerce, Inc. (PCCI) and Transparency and Accountability Network (TAN) were served together with the schedule of Pre-Bid conference, Bid Opening, Bid Evaluation and Post-Qualification;

WHEREAS, the BAC 4 conducted a Pre-Bid Conference on July 16, 2024 via Zoom through link Meeting ID 858 6285 0694 256108 and were attended by:

WHEREAS, upon thorough evaluation of the submitted bid for item 2 of Glenwood Technologies International, Inc and verification with the end-user, it is found to be sufficient and covers the function of item 6. Thus, item 6 is no longer necessary.

WHEREAS, BAC 4, in reference to section 41 of the 2016 revised IRR of RA9184 is cancelling item 6 for the procurement of various Laboratory Supplies (for Microbial tests).
