Recommending the Award of Contract for the Procurement of Various Stand-Up Pouches for Minola Products for San Pablo Manufacturing Corporation

**Project Number: SPMC-2024-013B (PhilGEPS# 11116234)**

**WHEREAS**, on 17 July 2024, the Bids and Awards Committee I (BAC 1) issued its Resolution No. SPMC-2024-013-BAC1-01 declaring the failure of bidding for the Procurement of Various Stand-Up Pouches for Minola Products for San Pablo Manufacturing Corporation due to ineligibility of the bidder;

**WHEREAS**, during the pre-procurement conference (held on 02 August 2024, the Bids and Awards Committee I (BAC 1) adopted the recommendation of the Technical Working Group to proceed with the 2<sup>nd</sup> public bidding for the procurement of Various Stand-Up Pouches for Minola Products for San Pablo Manufacturing Corporation;

**WHEREAS**, the aggregated Approved Budget for the Contract (ABC) of the abovementioned project is Six Million Two Hundred Fifty-Two Thousand Nineteen Pesos and 20/100 (Php 6,252,019.20);

**WHEREAS**, the detailed ABC is as follows:

**WHEREAS**, the BAC 1, through its Secretariat, advertised and published the Invitation to Bid (SPMC-2024-013B) for seven (7) calendar days from the date of its posting on August 5, 2024 on the following: (1) the PhilGEPS Web Portal (Reference Number **11116234**); (2) the Coconut Industry Investment Fund – San Pablo Manufacturing Corporation website; and (3) conspicuous places at the premises of the Coconut Industry Investment Fund – San Pablo Manufacturing Corporation;

**WHEREAS**, in compliance with the pertinent provisions of the 2016 Revised IRR of RA9184, the invitation to observers from Commission on Audit (COA), Philippine Chamber of Commerce, Inc. (PCCI) and Transparency and Accountability Network (TAN) were served together with the schedule of Pre-Bid conference, Bid Opening, Bid Evaluation and Post-Qualification;

**WHEREAS**, the BAC 1 conducted a Pre-Bid Conference on August 13, 2024 via Zoom through link Meeting ID 817 9957 0731 048364 and were attended by the following

**WHEREAS**, the BAC 1 issued a Notice of Postponement adjusting the date of bid opening posted on August 26, 2024 due to inability to establish the required quorum, which is attached hereto as Annex “A” and posted the same in the manner prescribed by pertinent laws;

**WHEREAS**, the BAC 1 issued a Notice of Postponement adjusting the date of bid opening posted on September 2, 2024 due to the declaration of suspension of work in government agencies in NCR brought about by typhoon “Enteng”, which is attached hereto as Annex “B” and posted the same in the manner prescribed by pertinent laws;

**WHEREAS**, the BAC 1, as certified by the Secretariat, received two (2) bid proposals for the above-mentioned procurement activity, to wit:
